**1. Rules**

- 1.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS) 2009-2011, and the Class Rules of the International Sunfish Class Association (ISCA), this Notice of Race and the Sailing Instructions.
- 1.2 If there is any conflict between this Notice of Race and the Sailing Instructions, the Sailing Instructions shall prevail.

**2. Entry**

- 2.1 This event is open to all Sunfish Class sailboats.
- 2.2 Competitors are required to be current members of the U.S. Sunfish Class Association (USSCA) and must present USSCA membership card at registration. Non-members may join at Registration. This is a World qualifying event.
- 2.2 Competitors may enter by completing the Registration Form and sending it, together with the entry fee described below (payable to Wawasee Yacht Club), to Linda Tillman, 6999 Eli Lilly Rd., Syracuse, IN 46567; or at Regatta Registration at the site.
- 2.3 Entry fee is \$45 (\$35 for Juniors under 18 years of age on August 27, 2010), postmarked on or before August 16. After that date, a late fee of \$10 will apply.
- 2.4 Entry fee includes racing, water on the course, two Continental breakfasts, two lunches, after race beverages, Saturday night dinner, regatta shirt, and awards for the top five overall, plus top Junior. Additional lunch and dinner tickets will be available at Registration.

**4. Racing/Scoring**

- 4.1 Races will take place on Lake Wawasee, north and east of the yacht club. Courses will be windward leeward or modified Olympic. Up to seven races will be sailed. Low Point Scoring, Appendix A4, will apply. If six or more races are sailed there will be one throw-out. One race constitutes a regatta. Sailing Instructions will be available at Registration.
